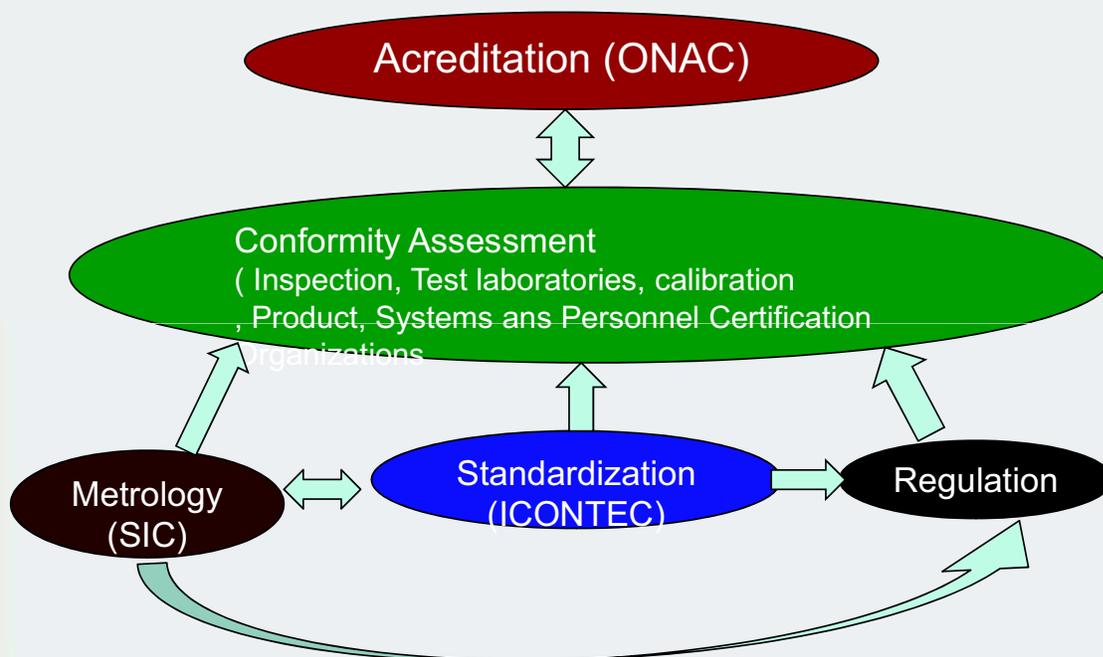


SQAM System

- Decree 1929 – Metrology System
- First approach to SQAM – 1984 (D. 2746)
- Actual SQAM – Decree 2269 year 1993
- CONPES 3446 of 2006 on Quality
- Decree 2269 Under revision

SQAM System

- The system is part of the “National competitive system”
- Follows international agreements and WTO directives
- Run at the top by Inter – sectorial Commission on Quality, headed by the Ministry of Commerce, Industry and Tourism



COMPONENTS SQAM

- Standardization
- Technical Regulations
- Accreditation
- Conformity Assessment
- Designation
- Metrology



STANDARDIZATION

- Private – ICONTEC is the NSB
- 5900 Colombian Technical Standards (NTC)
- 160 technical committees
- Follows the code of good practice according to annex 3 of the TBT (WTO)
- System based on credibility, transparency, openness and consensus



TECHNICAL REGULATION

- They are Mandatory
- Done by Public entities
- To protect Health, Safety, environment and Customer protection
- Need to be transparent, not discriminatory and based on International Standards
- They could be a major barrier to trade



ACCREDITATION

- ONAC – Organismo Nacional de Acreditación de Colombia
- Founded in 2007
- Mix of public and Private funding
- Accredites with ISO internationally recognized standards i.e: ISO 17021, 17024, 17025, 65
- More than 400 CAB accredited

DESIGNATION

- Designation: Authorization by a government entity to do CA in a particular Scheme (A kind of Accreditation??)
- Could be discriminatory
- It is sometimes used on very particular situations

- Test and Metrology labs.
- Inspection bodies
- Most CA organizations are private
- Needs international recognition

- National Metrology laboratory under the superintendance of Industry and Commerce (SIC)
- Carries – scientific – Industrial and Legal Metrology
- There is a chain of private metrology labs that provide calibration to Industry

- Important actor

- 1971 Quality Seal (Sello de Calidad)
- 1991 Management Systems Certification
- ISO 9001 – ISO 14001 – ISO/IEC 27001 – ISO 22000 – OSHAS 18001 – Others
- Special care of SMMIE in the country



SQAM Impact in the country

- The SQAM system has become important on these FTA, usually negotiated with WTO-TBT reach
- The lack of recognition of some actors in the system is a big problem
- There is a need of a well established Labs net



SQAM Impact in the country

- SMMIE have become active in the system
- More that 70% of affiliates to ICONTEC are SMMIE
- Management system certification to ISO 9001 with big increase (2nd in LA)
- Large growth of consultants on “Quality”
- Colombia is developing eight “world Class Sectors”



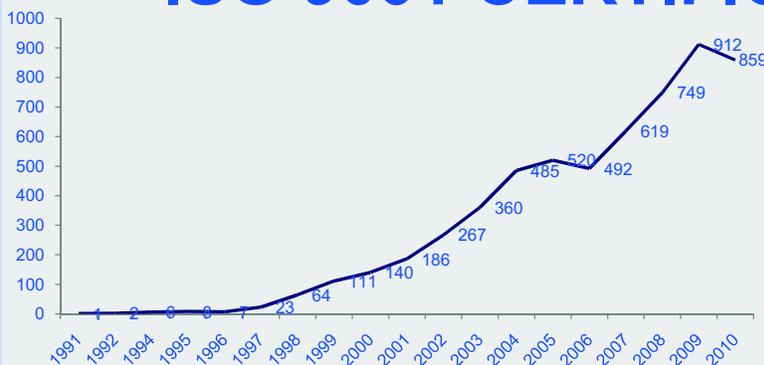

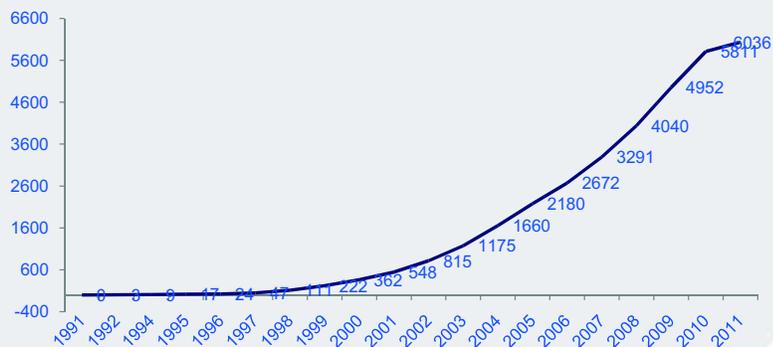

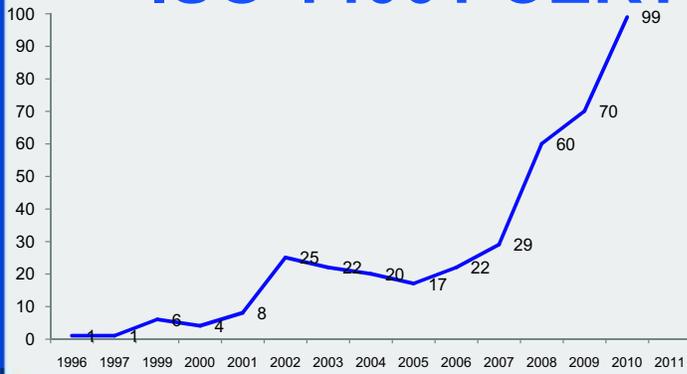

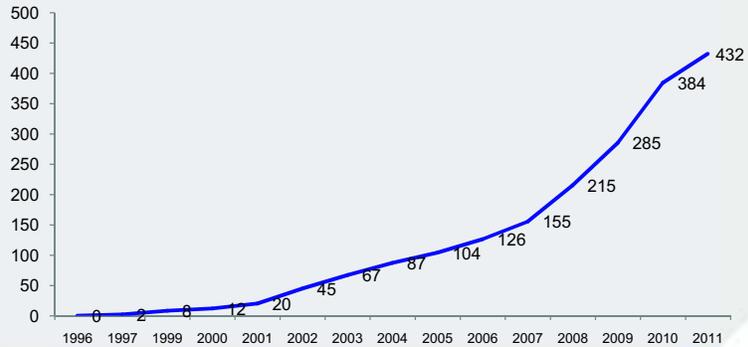


ISO 14001 CERTIFICATIONS



ISO 14001 certifications each year. There are 48 in 2011 up to april

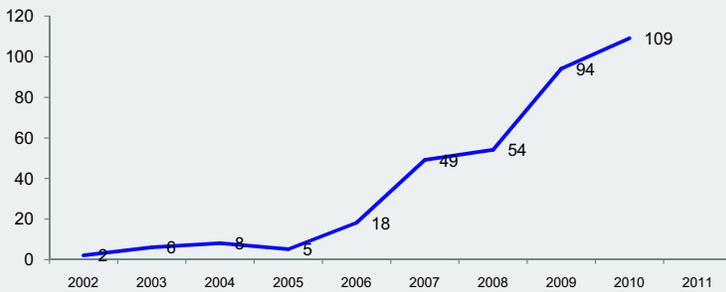
ISO 14001 total certificates

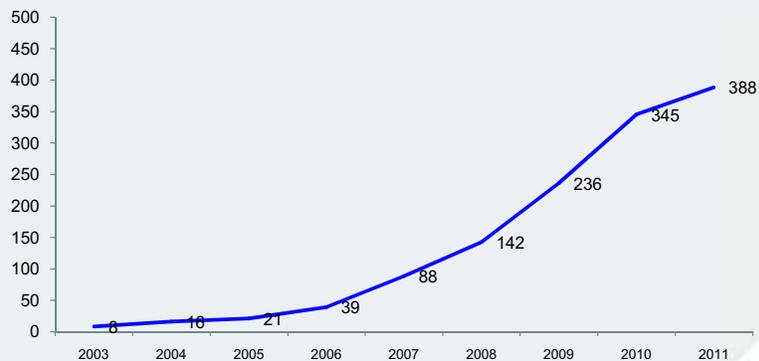


OHSAS 18001 CERTIFICATIONS

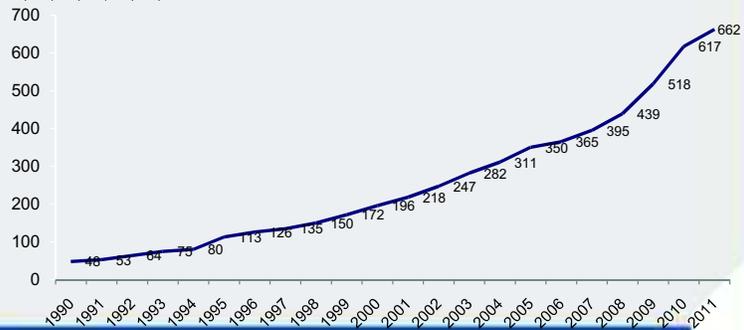
CERTIFICACION SELLO DE CALIDAD/SELLO CON REGLAMENTO

STRATEGIES

National Colombian Standards (NTC)

- A total of 5900 NTC
- NTC developed by consensus according to the needs of the government and Industry to boost competitiveness
- NTC based on International Standards
- 35% based on ISO, IEC, ITV
- 25% on US SDO (NFPA, ASTM, ASME, etc)

STRATEGIES

Subsidize programs to certify SMMIE

- SMMIE – Counts for 92 – 94% of enterprises
- Main certifications on the program ISO 9000 and 14000. More than 600 companies
- Programs financed by the IDB and the Colombian Government

STRATEGIES

Standards for small and Micro

- Program NOREXPORT
- Financed by IDB and later the EU
- More than 550 NTC
- Program with Bolivia (IBNORCA) and Perú (INDECOPI)



STRATEGIES

Special Management System Standards

- Designed to help small and micro enterprises.
- NTC 600 – Quality management system
- NTC 5520 – How to provide good service to customers.
- NTC 5555 – For “Informal” education institutions
- Guide to formalize companies



STRATEGIES

Standards as base for TR

- Technical regulations are mandatory and made by the government
- According to the WTO, they have to be based on international standards
- ICONTEC approaches the government so the TR don't become barriers to trade

Free Trade Agreements (FTA)

- Colombia has signed 7 FTA and there are 4 more in line
- On Negotiation FTA with: USA, the European Union, Korea, Panamá
- ICONTEC, as consultant to the government, participates
- FTA based on WTO - TBT

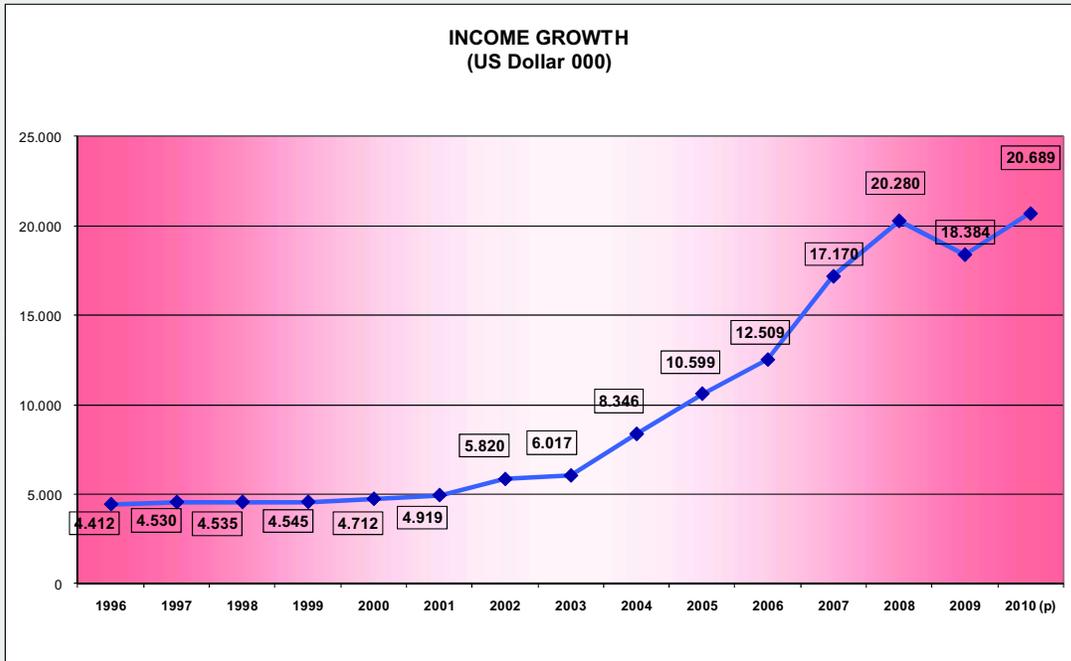

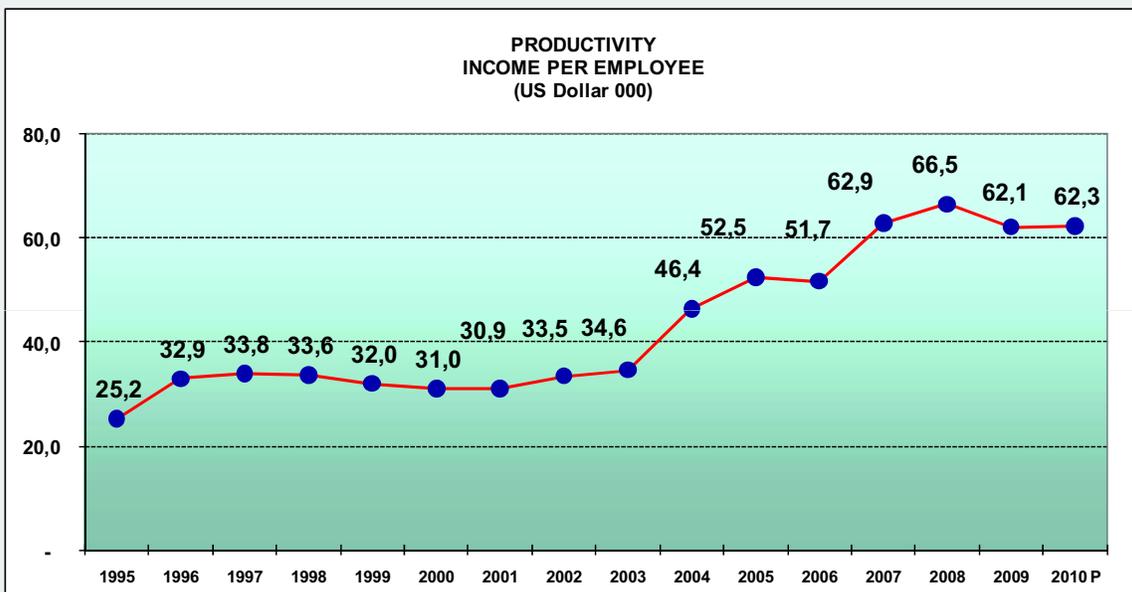
