EIGHTEENTH ANNUAL REVIEW OF THE IMPLEMENTATION AND OPERATION OF THE TBT AGREEMENT

NOTE BY THE SECRETARIAT¹

The WTO Committee on Technical Barriers to Trade (the Committee) will conduct its Eighteenth Annual Review of the Implementation and Operation of the WTO Agreement on Technical Barriers to Trade (the TBT Agreement) under Article 15.3 at its next meeting on 6-7 March 2013. This document contains information on developments in the Committee relating to the implementation and operation of the TBT Agreement from 1 January to 31 December 2012.

1 MEETINGS OF THE COMMITTEE

- 1.1. The Committee, pursuant to Article 13.1 of the TBT Agreement and to the Rules of Procedure, elected Mr. Salim Lahjomri (Morocco) as its Chairperson for the year 2012-2013.
- 1.2. Three meetings were held in 2012 (20-21 March, 13-15 June and 27-28 November 2012).² At these meetings, the Committee's attention was drawn to new or revised statements on implementation and administration of the Agreement, submitted under Article 15.2. In 2012, two Members submitted a new statement under Article 15.2, while six issued revisions to existing statements, and one issued a supplement to its statement.³
- 1.3. Ninety-four specific trade concerns, thirty-five of which were new concerns, were brought to the attention of the Committee with regard to the potential adverse trade effects of the measures, or possible inconsistency with the Agreement.⁴ Information on specific trade concerns is available through the TBT Information Management System (TBT IMS).⁵
- 1.4. During the reporting period, the Committee continued the exchange of Members' experiences on various cross-cutting issues related to the operation and implementation of the Agreement, including: good regulatory practice, standards, conformity assessment procedures, transparency and technical assistance.
- 1.5. At the meeting on 20-22 March 2012, the Committee adopted its report of the Seventeenth Annual Review of the Implementation and Operation of the TBT Agreement under Article 15.3 (G/TBT/31). At the same meeting, the Committee carried out the Seventeenth Annual Review of the Code of Good Practice for the Preparation, Adoption and Application of Standards (hereafter 'the Code'). This work was based on the following background documents: a list of standardizing bodies that have accepted the Code in the period under review (G/TBT/CS/1/Add.17), a list of standardising bodies that have accepted the Code since 1995 (G/TBT/CS/2/Rev.19) and the Seventeenth Edition of the WTO TBT Standards Code Directory, prepared by the ISO/IEC Information Centre.
- 1.6. At its meeting on 27-29 November 2012, pursuant to Article 15.4 of the TBT Agreement, the Committee concluded the Sixth Triennial Review of the Implementation and Operation of the TBT Agreement, and adopted the Review Report (G/TBT/32). The Review addressed the following topics: good regulatory practice, conformity assessment procedures, standards, transparency, technical assistance, special and differential treatment, and the operation of the Committee.
- 1.7. During the reporting period, representatives of the Codex, ISO, IEC, UNECE, ITC, OIML, ITU, UNIDO and WHO updated the Committee on activities relevant to the work of the TBT Committee, including on technical assistance. The Committee granted *ad hoc* observer status to the *Bureau International des Poids et Mesures* (BIPM).

2 MECHANISMS FOR REVIEW OF TBT MEASURES⁶

2.1 Notifications

2.1.1 Technical regulations and conformity assessment procedures


2.1. In 2012, Members submitted 1,550 new notifications (including revisions) of technical regulations and conformity assessment procedures along with 575 addenda and 45 corrigenda to notifications. Since the entry into force of the Agreement on 1 January 1995, up to 31 December 2012, 15736 notifications, 2,684 addenda and 485 corrigenda to these notifications have been made by 116 Members.

2.2. Among the 1,550 notifications received in 2012, the following objectives were mentioned by Members: protection of human health or safety; prevention of deceptive practices; quality requirements; protection of the environment; adoption of new technology; protection of animal or

plant life or health; harmonization; consumer information and labelling; cost saving and increasing productivity; and trade facilitation (See Table 1).

2.3. In 1995, the Committee recommended that the normal time-limit for presentation of comments on notified technical regulations and conformity assessment procedures should be 60 days. Moreover, it was recommended that any Member able to provide more than 60 days, such as 90 days, was encouraged to do so. In 2012, Members allowed an average of 56.6 days for comments in the 1,339 cases where they specified a comment period. In total, 86 notifications did not specify a comment period, stated it as non-applicable, or had a comment period which had lapsed (see Annex B). Chart 3 shows the average time allowed for comments since 1995.




Chart 3: Average Number of Days Allowed for Comments since 1995¹⁰

2.1.2 Notifications under the Code of Good Practice for the Preparation, Adoption and Application of Standards ("the Code")

2.4. In 2012, there were no notifications of acceptance nor withdrawal from the Code. Since the entry into force of the Agreement and through December 2012, 162 standardizing bodies from 122 Members have adhered to the Code. 11 Document G/TBT/CS/2/Rev.19 contains a list, by Member, of standardizing bodies that have accepted the Code since 1 January 1995 through December 2012. The ISO/IEC Information Centre prepared the Seventeeth Edition of the WTO TBT Standards Code Directory which lists all standardizing bodies that have notified their acceptance of the Code.

2.1.3 Notifications under Article 10.7

2.5. In 2012, Ukraine notified agreements under Article 10.7 with the Czech Republic, Former Yugoslav Republic of Macedonia, Latvia, Libya, Slovak Republic, Spain, Switzerland, Tunisia, the United States and Viet Nam on the recognition for Conformity Assessment Procedures. Since the entry into force of the TBT Agreement, Members have submitted 137 notifications under Article 10.7 along with 6 corrigenda to these.

2.2 Specific Trade Concerns

2.6. Since its first meeting, Members have used the TBT Committee as a forum to discuss issues related to specific measures (technical regulations, standards or conformity assessment procedures) maintained by other Members. These are referred to as "specific trade concerns" and relate variously either to proposed measures notified to the TBT Committee in accordance with the notification requirements in the Agreement, or to measures currently in force. Committee meetings, or informal discussions between Members held in the margins of such meetings, afford Members the opportunity to review trade concerns in a bilateral or multilateral setting and to seek further clarification. Members regularly discuss follow-up in the Committee. In 2012, 94 specific

trade concerns were raised (see Annex C). The following Charts provide information on the 365 concerns raised to date.

2.2.1 Types and Number of Specific Trade Concerns Raised

2.7. In 2012, 35 new concerns were raised and 59 previously raised concerns were discussed. Chart 4 illustrates the number of specific trade concerns addressed by the Committee each year since $1995.^{13}$




Chart 4: Number of specific trade concerns raised per year

2.8. In discussions at the Committee between 1995 and 2012, the most frequently invoked concerns were those relating to the need for more information, or clarification about the measure at issue. Concerns relating to the avoidance of unnecessary barriers to trade and to lack of transparency are also frequent.




Chart 5: Types of concerns raised in 1995 - 2012¹⁴

2.9. In 2012 alone, concerns regarding unnecessary barriers to trade were less frequently raised in comparison to previous years. Concerns regarding the rationale and legitimacy of a measure were, however, raised more frequently.




Chart 6: Types of concerns raised in 2012

2.10. About 70% of the measures discussed in the Committee have been notified. ¹⁵ Measures notified as technical regulations (Articles 2.9.2, 2.10.1) are most frequently discussed (Chart 7). ¹⁶




Chart 7: Specific trade concerns relating to measures that have been notified

2.2.2 Stated Objectives

2.11. Information about the stated objective of measures may be derived from the notification itself, or, when raised in the Committee, through the discussion in the Committee. The most commonly stated objectives of the measures discussed relate to health and safety, and the protection of the environment. The category 'other' covers a wide range of stated objectives including: consumer protection, consumer information, fair trade and trade facilitation. For a significant number of trade concerns, the objective is not readily apparent from discussions and there is no notification; these stated objectives have been classified as "not specified" in Chart 8.




Chart 8: Stated objectives for the measures in 1995 - 2012¹⁷

2.12. For the measures raised in 2012, the protection of human health and safety continued to be the dominating objective. Moreover, in contrast long-term average, in 2012 there were more

measures that addressed consumer information and labelling than prevention of deceptive practices and other objectives.




Chart 9: Stated objectives for the measures in 2012

2.2.3 Distribution of Measures by Member

2.13. By and large, the distribution of measures subject to discussion in the Committee reflects an even regional spread across the WTO membership, with the exception of African and Caribbean countries. ¹⁸ No measures maintained by LDCs have been raised in the TBT Committee.




Chart 10: Regional distribution of measures raised for discussion¹⁹

2.14. Chart 11 illustrates how frequently concerns with one particular measure are raised in Committee meetings. Most (59%) specific trade concerns have been raised once or twice. Some, however (14%), have been raised more than five times, and, amongst these, several have been on the agenda for a number of years.

2.15. Measures maintained by the European Union, China and the United States have been most frequently raised for discussion in the Committee (Chart 12).




Chart 12: Members whose measures have been most frequently discussed

3 DISPUTES INVOLVING PROVISIONS OF THE TBT AGREEMENT

3.1. During the review period, three Appellate Body reports and panel reports were adopted that are of particular relevance to the TBT Agreement (in reverse chronological order):

- a. United States Certain Country of Origin Labelling (Cool) Requirements (Complainants: Canada and Mexico). At its meeting on 23 July 2012, the DSB adopted the Appellate Body report and the panel report, as modified by the Appellate Body report.²⁰
- b. United States Measures Concerning the Importation, Marketing and Sale of Tuna and Tuna Products (Complaint: Mexico). At its meeting on 13 June 2012, the DSB adopted the Appellate Body report and the panel report, as modified by the Appellate Body report.²¹
- c. United States of America Measures Affecting the Production and Sale of Clove Cigarettes (Complainant: Indonesia). At its meeting on 24 April 2012, the DSB adopted the Appellate Body report and the panel report, as modified by the Appellate Body report.²²
- 3.2. In addition to the above mentioned disputes, since the entry into force of the Agreement, some 39 other cases cite the TBT Agreement in their request for consultations. A full listing of these cases can be found on the WTO website under "Disputes by Agreement".²³

4 TECHNICAL ASSISTANCE

4.1 Regional Workshops

4.1. In 2012, the Secretariat organized one regional workshop for Caribbean countries in Grenada from 21-23 November 2012. The programme of this workshop was designed to assist participating economies from the Caribbean region to consolidate knowledge of the principles and disciplines of the TBT Agreement.

4.2 National Workshops

4.2. In response to requests received from individual Members, workshops were held in Montenegro, Croatia, Uganda, Ethiopia, the Maldives, Cuba, Dominican Republic and Belarus during 2012. These workshops aimed at: promoting a better understanding of the TBT Agreement; enabling a discussion of challenges in the implementation of this Agreement; and, (iii) providing an opportunity to address issues of specific interest to these Members.

4.3 Trade Policy Courses

4.3. TBT training was also provided in the trade policy courses organized by the WTO Secretariat, both Geneva-based and regional. Training sessions on the TBT Agreement were organized in the trade policy course held in Geneva on 7 February 2012, 8 May 2012 and 9 October 2012 and in the regional trade policy courses held in Colombia (for Latin American countries) on 22-23 March 2012, Swaziland (for English-speaking African countries from 19-20 June 2012), Turkey for Central and Eastern Europe, Central Asia and the Caucasus Countries (CEECAC) from 3-4 October 2012, India (for Asia and Pacific countries) from 29-30 October 2012, and Kuwait (for Middle Eastern countries) on 5 December 2012.

4.4 E-Learning

4.4. In 2012, 207 participants successfully completed TBT e-training courses (102 participants in English, 57 participants in French, and 48 participants in Spanish). The TBT-online course is

addressed to government officials from Members and Observers and covers all aspects of the TBT Agreement. The TBT on-line course is available throughout the year in all three languages.²⁴
