#### 1.2 Main developments of the Committee during the current period

The Committee held its twenty-fourth, twenty-fifth and twenty-sixth meetings on 30 March, 29 June and 9 October (G/TBT/M/23-25) respectively. At those meetings, the Committee heard statements concerning the implementation and administration of the Agreement, technical assistance and observer status. A number of Members informed the Committee of measures taken to ensure the implementation and administration of the Agreement. Several measures were brought to the attention of the Committee by Members who raised concerns about the potential adverse trade effects or inconsistency with the Agreement of those measures. A number of observers (ISO, ITC, UNIDO, FAO/WHO Codex Alimentarius, IEC, OIML and the World Bank) updated the Committee on their technical assistance activities and on the ways in which they sought to ensure effective participation of Members, in particular developing country Members in their activities.

At its twenty-fourth meeting, the Committee carried out its Sixth Annual Review of the Implementation and Operation of the Agreement under Article 15.3 (G/TBT/10) and its Sixth Annual Review of the Code of Good Practice for the Preparation, Adoption and Application of Standards in Annex 3 (G/TBT/CS/1/Add.5, G/TBT/CS/2/Rev.7 and WTO TBT Standards Code Directory – Sixth addition).

In order to give Members the opportunity to discuss the activities and problems relating to information exchange and to review how well notification procedures work, a special meeting on procedures for information exchange was held on 28 June. A number of proposals to improve information exchange were made at the meeting for the consideration of the Committee.

As a result of the Second Triennial Review of the Agreement, at its twenty-fourth, Twenty-fifth and twenty-sixth meetings, the Committee held discussions to develop a demand driven TBT-related Technical Cooperation Programme.

## 3.1 Notifications made in the current year and since the entry into force of the Agreement by Members and by the relevant Articles of the Agreement

In 2001, Members submitted 538<sup>4</sup> notifications. Since the entry into force of the Agreement on 1 January 1995 up to 31 December 2001, 4085 notifications have been made by 65 Members. Articles 2.9, 2.10, 3.2, 5.6, 5.7 and 7.2 were specified in 3623, 142, 3, 296, 49 and 3 notifications respectively. 117 notifications did not refer to any Articles.

#### Observation of the recommended comment period by Members in the current year<sup>9</sup> 3.1.2

The Committee has recommended 60 days as a minimum length of time to be allowed for the presentation of comments from other Members (G/TBT/1/Rev.7). In 2001, Members allowed an average of 53.34 calendar days for comments. 143 notifications did not specify a comment period, stated as non applicable or had a lapsed comment period. In 2001, the Secretariat held and participated in seminars on the Agreement and its related matters with the cooperation of the Codex, Energy Charter Secretariat, Inter-American Development Bank, ISO, ITC, UNIDO, World Trade Institute and Swiss government. They were held in Austria, Chinese Taipei, Colombia, Ethiopia, Kuwait, Oman, Switzerland, Vietnam and Yugoslavia for Andean and Central American, Asian, Central and Eastern European, Eastern African, Gulf and a

number of other developing countries. Funds were provided by the WTO to finance participants attending the Seminar in Ethiopia.

## VII. CODE OF GOOD PRACTICE FOR THE PREPARATION, ADOPTION AND APPLICATION OF STANDARDS

Since the entry into force of the Agreement, 138 standardizing bodies from 94 Members have adhered to the Code of Good Practice. Notifications of acceptance of the Code by standardizing bodies of Members are contained in documents G/TBT/CS/N/1-140<sup>10</sup>. Document G/TBT/CS/2/Rev.8 contains the complete list by Member of standardizing bodies that have accepted the Code since 1 January 1995. A list of standardizing bodies adhered to the Code in 2001 is contained in document G/TBT/CS/1/Add.6. In 2001, 14 standardizing bodies from 13 Members have accepted the Code.

The seventh edition of the WTO TBT Standards Code Directory will be published by the ISO/IEC Information Centre in February 2001.
